





STRUCTURE OF ALCOHOL CONSUMPTION, 100 % ALCOHOL IN 1995-2004






INDIVIDUALS CONSUMING ALCOHOL WEEKLY IN 2003 12-18-year-olds



15-16-year-olds









15-16-year-olds







Deliveries to licensed serving, litres


